PACKAGING RECYCLABILITY

DESIGN FOR RECYCLING CERTIFICATION

SCOPE

Evaluates and ranks the recyclability of plastic packaging, determining to which extent it is suitable for its dedicated sorting and recycling streams.

ELIGIBILITY

Final plastic package which are entirely covered by the RecyClass Design for Recycling Guidelines.

VALIDITY

- 3 years
- Europe-wide

OUTCOME

- Certificate with class from A to F for the technical sortability and recyclability of plastic packaging on the EU market, based on the state-of-the-art sorting and recycling technologies.
- B2B communication.

RECYCLABILITY RATE CERTIFICATION

SCOPE

Certification of a final package which is designed to be recycled, and is effectively recycled in the specified geographical area. Existence of selective collection schemes, as well as of sorting and recycling infrastructures is assessed.

ELIGIBILITY

Final plastic package which is entirely covered by the RecyClass Design for Recycling Guidelines and pledged on the market of the audited geographical area / country.

VALIDITY

- 3 years
- Country-specific

OUTCOME

- Certificate with class from A to F and scoring from 0 to 100% for the technical sortability and recyclability of plastic packaging, in accordance with the technologies & infrastructures of a given region.
- B2B & B2C communication.
- On-pack use of certification mark.

LETTER OF COMPATIBILITY

SCOPE

Evaluates and ranks the recyclability of semi-finished plastic packaging, determining to which extent it is suitable for state-of-art sorting and recycling streams.

Destined mainly for converters and limited B2B communications only.

ELIGIBILITY

Semi-finished package which is entirely covered by the RecyClass Design for Recycling Guidelines

VALIDITY

- 3 years
- Europe-wide
- B2B communications

OUTCOME

- Letter with class from A to F for the technical sortability and recyclability of semi-finished packaging. The final recyclability class for the finished packaging may be affected by features outside of the scope of the Letter.
- B2B communication.

RECYCLED PLASTICS TRACEABILITY CERTIFICATION

SCOPE

Enables all actors of the plastics value chain to demonstrate a transparent use of recycled plastic in products. It focuses on the traceability of recycled plastics within a process and the declaration of a percentage of recycled content in products. The Audit Scheme requirements were developed in line with **EN 15343:2007** and follow the principles of a controlled blending approach chain of custody model (**ISO 22095**). The Scheme was evaluated by the European co-operation for Accreditation & can be used as a valid proof when applying for the Spanish Tax deduction.

ELIGIBILITY

All plastic products with recycled content.

VALIDITY

- 1 year

OUTCOME

- Certificate states the share of recycled content in the audited products and demonstrates that the right procedures are in place within a process to ensure traceability of the recycled plastics.
- B2B & B2C communication.
- On-product use of certification mark.

COST: A fixed management fee covering the application costs, is applied per certificate. In addition, the audit costs will vary depending on the choice of the independent recognised RecyClass Certification Body.



RECYCLED PLASTIC

RECYCLING PROCESS CERTIFICATION

SCOPE

Certification focuses on the verification of the origin of waste, the traceability throughout recycling processes and the calculation of recycled content in the output. The Audit Scheme covers the requirements to be met by recyclers concerning traceability according to **EN 15343:2007**, quality management systems and environmental and administrative operating performance for the recycling of waste, as well as chain of custody. The Scheme was evaluated by the European co-operation for Accreditation, as well as recognised by the Blue Angel ecolabel. Additionally, it is an equivalent to EuCertPlast Certification.

ELIGIBILITY

All recyclers capable of recycling pre-consumer and/or post-consumer plastic waste into new plastic products.

VALIDITY

- 1 year

OUTCOME

- Certificate include the final statement of conformity of the recycling process against the audit requirements and details of the audit.

ASSESSED BY THE RECYCLASS TECHNICAL COMMITTEES

The results of the testing, based on the RecyClass Recyclability Evaluation Protocols, are evaluated by the RecyClass Technical Committees where Platinum members participate.
