DISCLAIMER

RecyClass recognition applies only to MAIC Europe Ltd. 'MAICWash H10' technology reported in Annex I. The recyclability assessment therefore does not refer to the testing of a specific packaging using this pressure sensitive adhesive. Any specific packaging using this pressure sensitive adhesive would need to be tested individually to demonstrate that the system of resin, adjuvants, label, closure, and printing conforms to the RecyClass Recyclability Evaluation Protocol for PET bottles, and that it is sorted in the PET bottle stream at the state-of-art sorting plants in Europe.

Publication of results of testing of this technology MUST clearly include all the conditions listed in the approval letter. Partial reporting of the conditions is forbidden.

Additionally, any change in the formulation of the technology must be communicated to the Technical Committee which will reassess the approval of the technology.

The RecyClass PET Technical Committee was requested to carry out an assessment of the technology 'MAICWash H10' by MAIC Europe Ltd. to verify its impact on the quality of recycled PET bottles.

The 'MAICWash H10' technology is a wash-off hotmelt rubber pressure sensitive adhesive, applied with a PP-based label on a clear transparent PET bottle, without cap. The label facestock coating basis is 54 gsm and the adhesive coating weight is 15 gsm.

According to the results that were obtained from the laboratory tests done by the PolytoPoly, carried out as per the Recyclability Evaluation Protocol for Labels & Adhesives applied on PET bottles (version 1.0), 'MAICWash H10' technology is <u>fully compatible with PET bottles recycling.</u>

Based on these results, RecyClass acknowledges that MAIC Europe Ltd. 'MAICWash H10' technology will have no impact on the current European PET bottles recycling and provided that the full packaging using this pressure sensitive label is designed under the following conditions¹:

- a) The packaging is made of PET;
- b) The hotmelt rubber adhesive is 'MAICWash H10' from MAIC Europe Ltd. and the adhesive coating weight is 15 ± 2 gsm;

¹ PET bottles designed under conditions other than those indicated need to be tested to assess their compliance with RecyClass Recyclability Evaluation Protocol for PET bottles.

c) The facestock of the pressure sensitive label applied on the packaging is made of PO (density below 1 g/cm 3);

d) Any additional component or features (e.g. inks) of the packaging must be compliant with the corresponding RecyClass Design for Recycling Guidelines².

RecyClass concludes that MAIC Europe Ltd. 'MAICWash H10' technology as per current market conditions and knowledge, is fully compatible with the existing European industrial recycling processes for PET bottles.

In regard to RecyClass Recyclability Certification, the present full compatibility with PET bottles recycling approval delivered to MAIC Europe Ltd. 'MAICWash H10' technology, means that a packaging containing this technology, as mentioned in the aforementioned conditions will not be penalised with a recyclability class deduction. Moreover, the amount of recyclable PET will impact the final Recyclability Class obtained during Recyclability Certification and should be kept above 95 % or 80 % in the final packaging to maximise chances to get a Recyclability Certificate with a Class A or B, respectively³. Also, it is noteworthy that the presence of additional packaging features could impact the certification process.

This approval letter is valid for 2 years from the date mentioned in this document. After this time, RecyClass PET TC will evaluate the reassessment of this technology or the potential extension of the validity period.
